#### 1. Legal Advice

Providing legal advice and legal solutions to foreign, multinational companies related to potential disputes in the field of civil litigation in Indonesia, such as providing legal advice and solutions regarding contract disputes or arbitration disputes, commercial or business disputes, disputes between shareholders, land disputes, family law disputes, bankruptcy and Suspension of Debt Payment Obligation (PKPU) disputes, employment disputes and state administrative disputes.

- Assisting, cooperating, providing legal advice and legal solutions to lawyers from foreign law offices from Singapore, Malaysia, Hong Kong, China, Japan, England, France, and the United States, related to potential disputes in the field of civil litigation in Indonesia, such as providing legal advice and solutions regarding contract disputes or arbitration disputes, commercial or business disputes, disputes between shareholders, land disputes, family law disputes, bank-ruptcy and PKPU disputes, employment disputes and state administrative disputes.
