Representatives List/ Types of Work Undertaken

1. Litigation

- Act for foreign capital investment companies and multinational clients in complex civil litigation before Indonesian courts, including proceedings at the Bekasi District Court and Bandung Industrial Court, involving claims of up to USD3.1 million.

2. Arbitration

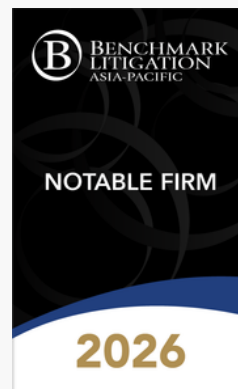
